About This Report

This is NBI/Michael Sone Associates' fourteenth report on the Canadian Local Telecom Services Market. Information, both quantitative and qualitative, was analyzed and organized so as to provide the reader with a detailed understanding of the background, current state and probable future of the local services sector. The final product, Canadian Local Telecom and VoIP Services Market Report, 2013 Edition, is the most detailed research report available on this industry.

The local services market will experience a myriad of developments over the coming months that NBI/Michael Sone Associates will continue to track.
